### **Cancelling Membership**

A cancellation fee of \$250 will be charged to Play Pass Holder by Carter Plantation, if its Play Pass is cancelled after 30-day grace period expires, such cancellation fee due upon cancellation.

### **Payment**

Carter Plantation requires a credit card or banking information on file for all Play Pass Holders. Monthly Play Passes and Credit Account charges will be processed by credit card or banking information on the first day of every month. In the event of any change in payment information, please contact Carter Plantation immediately.

### **Cart Fees**

Play Pass Holders who are not parties to a cart plan are required to pay a cart fee upon playing. Cart fees are \$18 for 18-hole rounds and \$12 for 9-hole rounds. At Carter Plantation, Play Pass Holders can walk or use a pushcart at no charge.

### **Rules and Regulations**

Play Pass Holder agrees to follow all guidelines set forth by Carter Plantation. Guest(s) who accompany Play Pass Holders are subject to pay the full green fee rate and are bound by all guidelines set forth by Carter Plantation.

### **Discounts**
